You have asked that we provide you with further information regarding a Federal credit union's ("FCU's") duties and responsibilities concerning its acceptance of 401k shares. In our October 13th letter to you, we discussed the legal requirements imposed by the FCU Act and NCUA's Rules and Regulations that an FCU must comply with to accept such shares. The FCU's other duties and responsibilities concerning maintenance of a 401k program are not within NCUA's jurisdiction and should be addressed by the FCU's attorney.
